Tobacco Cessation and Oral Cancer Awareness



Oral cancer is the largest group of cancers that fall into the head and neck cancer category, which includes mouth, tongue, head and neck, and throat cancer. According to the [National Institutes of Health](#), only 68 percent of people diagnosed with oral cancer survive more than five years. Those who do survive may suffer long-term problems, such as severe facial disfigurement or difficulties with eating and speaking. The reason for such a high mortality rate is that these cancers are usually found in late-stage development. The best method to detect oral cancer in its early stages is through regular oral cancer examinations by a dental provider or oral health professional.

Quick Statistics:

Oral Cancer Relative Survival (2012–2018)

- Overall, 68% of people with oral cancer survive for 5 years.
- Oral cancer survival rates are significantly lower for Black and American Indian/Alaska Native men and women.
- Diagnosing oral cancer at an early, localized stage significantly increases 5-year survival rates.

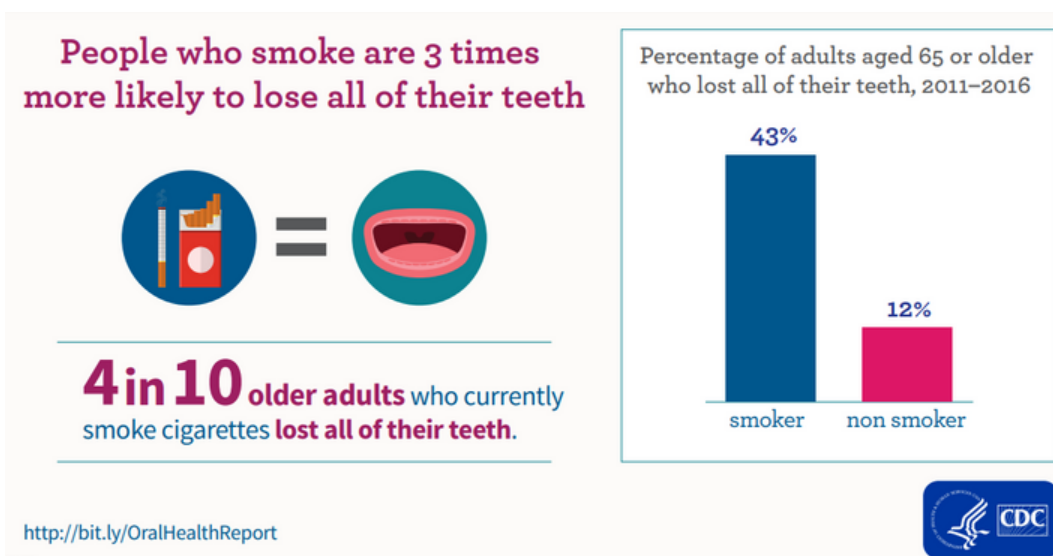

Oral Health, Tobacco, & Nicotine

It is well documented that smoking and other tobacco use can cause oral health problems, such as oral cancer, gum disease, tooth loss, slowed healing after oral procedures, tooth staining, and bad breath.¹ For individuals who smoke or use smokeless tobacco, quitting tobacco and nicotine is one of the best things they can do for their oral health.



The California Oral Health Plan includes a goal to increase the percentage of patients who receive evidence-based tobacco cessation counseling and other cessation aids in dental care settings. However, dental health professionals may not always have the time or experience to provide these cessation services. That's where [Kick It California](#) (KIC) comes in!

KIC Free Cessation Services

KIC, formerly the California Smokers' Helpline 1-800-NO-BUTTS, has served more than 1 million people since the program started in 1992. It is funded by the California Department of Public Health, Centers for Disease Control, and First 5 California.

Ask, Advise, Refer

People are more likely to get KIC Quit Coaching when referred by their healthcare provider. Providers have options for referring their patients to KIC. Visit KickItCA.org/health-professionals to learn more.

KICK IT California

What happens after referral?

- QUIT COACH CALL**
Quit Coach will call within 2 business days of receiving the referral.
- QUIT PLAN**
Quit Coach will help create a personalized Quit Plan.
- QUIT AIDS**
Most smokers qualify for free nicotine patches delivered to their home.

After the first call, a **Quit Coach** will proactively follow up with the person at key points after they've quit, to help them stay motivated and to increase their chances of **quitting for good**.

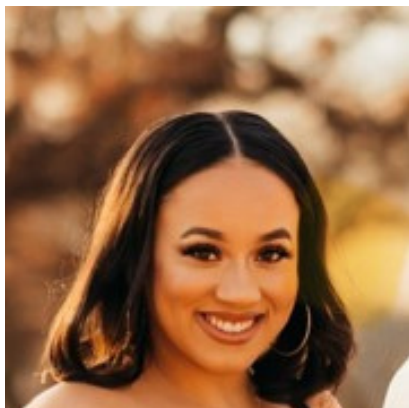
CDA HPV and Dentist Champions Resource

California Dental Association released a new resource for dentists to support their promotion and education of HPV vaccination. To support dentists as champions for disease prevention, CDA outlines tips for talking about HPV, how to respond to common questions, and where the highest need for HPV promotion is in the state. In California, there are disparate HPV vaccine rates by county, which jeopardize the health of California's most vulnerable communities. Furthermore, counties with lower HPV vaccination have higher HPV- attributable cancer rates.

Oropharyngeal cancer is now the most common cancer attributed to HPV in the United States, surpassing rates of cervical cancer recorded in 2019. By increasing HPV vaccination rates, healthcare providers, including dentists, would be able to prevent thousands of cancers. Dentists have a unique role in supporting HPV vaccination as they are often the primary detector of HPV-related oral cancers. LOHP Spotlight: Nevada County



Nevada County, California, is in the western slope of the Sierra Nevada foothills and has a population of roughly 102,000. The county is rural with deep historical significance from the gold rush era and is home to the historic towns of Grass Valley, Nevada City, and Truckee. The area is a nature lover's paradise with many hiking trails, lakes, and the famous Yuba River.

For National Children's Dental Health Month (NCDHM), the Nevada County Oral Health Program (NCOHP) wanted to bring awareness to the importance of children's oral health and how public health is working to address the needs of the community through a school-based dental program.

Continued LOHP Spotlight: Nevada County



The program focuses on education, screenings, prevention, and providing a pathway to care in a community underserved by Medi-Cal providers and affordable dental care. This school year, approximately 500 students have been screened, mostly for Kindergarten Oral Health Assessments.

In honor of NCDHM, the program announced it was expanding screenings to second and third graders for sealants and other treatment recommendations. Thirty-five second and third graders were screened at Scotten Elementary in Grass Valley. “We hope that the screenings will help families without a dental home find a pathway to the care they need,” said Program Coordinator, Jamie Hanf.

Students with Medi-Cal will have the option to receive preventive treatment services with a Registered Dental Hygienist in Alternative Practice (RDHAP) on a second visit after their initial screening. Students without insurance are encouraged to sign up for Medi-Cal to take advantage of what the school-based program offers.

By expanding the program and making preventive services more available, the NCOHP is addressing key barriers to good oral health facing children and families in Nevada County. The NCOHP Coalition website, SmileNevadaCounty.com, provides education and local resources.
