



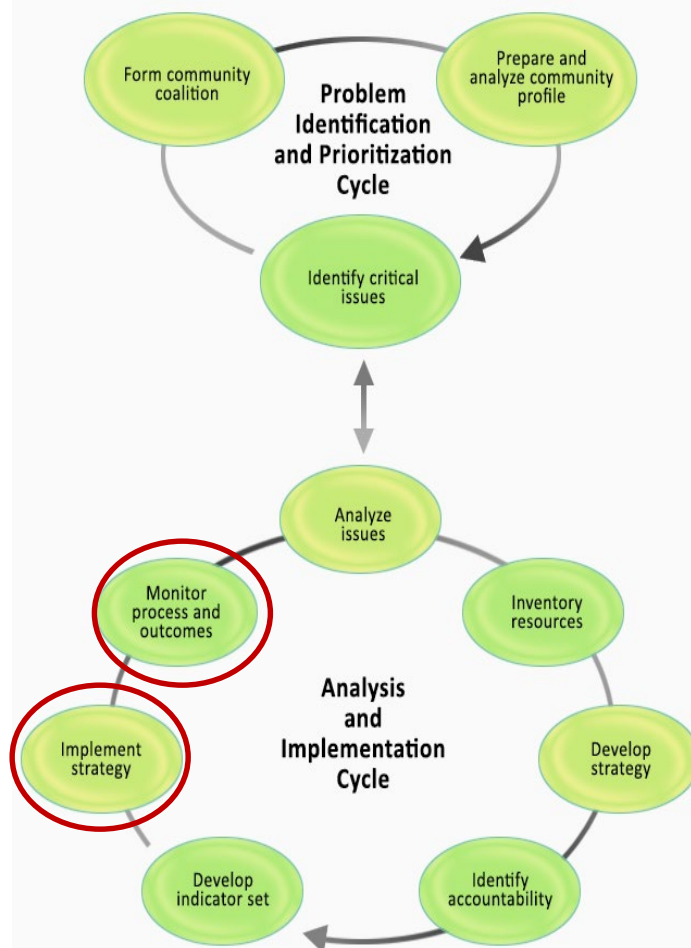

- Conduct surveillance and evaluation

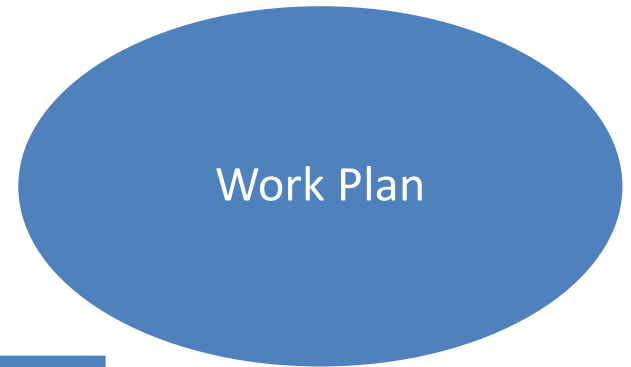
