Moving California Oral Health Forward 2022-2027 Request For Applications

Welcome and Introductions

- ▶ We are excited to announce the extension of the LOHP, Prop 56 funding in the 2022 2027 Moving California Oral Health Forward Grant!
- Implement the strategies of the California Oral Health Plan and improve the oral health status of all Californians.
- ▶ All 61 California LHJs or their designee agencies are eligible.
- Grant is non-competitive. All complete applications will be considered for final funding awards.

Message from the California Dental Director




Purpose of Funding



- Supports development or expansion of a local oral health program.
- Creates and expands capacity at the local level to educate, prevent, and provide linkages to treatment programs.
- Supports program activities related to oral health in communities, such as education, disease prevention, community-clinical linkages, and surveillance.
- Improves the oral health of Californians and prioritizes underserved areas and populations.
- ▶ All WP activities are intended to support achieving a 50% reduction in racial disparities in oral health outcomes among school-aged children in California by 2030.

Funding Mechanism: Subvention/Local Assistance Grant

- Marks the continuation into a new 5-year grant/funding cycle.
- Although grant is intended for health departments, designee agencies in LHJs may also be considered as applicants if a health department declines funding.
- ► CDPH will review applications received, assign new contract numbers, and produce contract documents for LHJ signature.
- Local approval processes may vary. If LHJ Board of Supervisors approval is required, please build this into your timeline.
- LHJs who accept funding will develop budgets for their supplemental submissions.
- ▶ July 2022 June 2027 implementation period.



2022-27 Minimum Grant Activities and Reporting/Tracking Measures of Objectives Requirement Summary By Funding Tier

Legacy Local Oral Health Programs

► The Agency application must align with the Grant Activities and Reporting/Tracking Measures of Objectives minimum requirements described in Appendix 1, Table 2, page 9. Legacy Local Oral Health Programs (LOHPs) who participated in the 2018 – 2022 grant cycle are responsible for all Grant Activities and Reporting/Tracking Measures for objectives 1 – 7 for the entire grant term.

LHJs or designees who are newly establishing

► LHJs or designees who are newly establishing LOHPs must select all Grant Activities and Reporting/Tracking Measures for objectives 1 – 3 and will be responsible for selecting all activities for one additional objective (from objectives 4 – 7) of their choice for the entire grant term. (Please refer to Exhibit A).

What's New

- ▶ In the 2022-2027 grant cycle, the first objective will be to establish or sustain program infrastructure, partnerships, and processes to ensure implementation and evaluation of the Work Plan.
- New programs will need to start by establishing oral health infrastructure.
- Objective 1 is essentially composed of the first 5 objectives in the original grant.

What's New continued

Two major focus areas of the next 5-year cycle will include:

- Objective 2, implement evidence-based programs to achieve California Oral Health Plan objectives, will be a priority during this 5-year grant cycle. The objective contains planning steps to support the development of community-clinical linkages and school-based/ school-linked programs.
- Objective 3, assess the number of schools currently not reporting Kindergarten Oral Health
 Assessments (KOHA) and increase reporting via the System for California Oral Health Reporting
 (SCOHR).
- Objective 3 will also develop and implement a plan to identify and recruit Key Partners to support
 oral health integration into local programs that work with underserved and vulnerable populations.

New Activities

- Provide quality improvement (QI) coaching or trainings to primary care offices and CBOs to improve services provided to underserved areas and/or vulnerable populations.
- Implementing performance management activities and software.
- Success Stories, identifying new and engaging formats such as a photovoice to share with local programs, policymakers, stakeholders, and the general public to help sustain program efforts.

- ► Please let us know ASAP if for any reason your LHJ does not intend on accepting funds for next 5 years. Using the non-binding Letter of Intent is encouraged.
- After reviewing completed applications, OOH will notify LHJs of decision to award.
- Supplemental submission will allow LHJs more time for budget planning.
- ► LHJs navigate internal review processes beginning in Fall/Winter and through Winter/Spring 2022. Please let us know if you have any special requests for getting on your Board's agenda.
- Work can be expected to begin July 1, 2022.

Where to Get Started

- Research your Board approval process, if you are unfamiliar.
- Please contact your Program Consultant if you live in a rural or underserved area where provider availability will be a challenge to school dental program implementation.
- Review your progress over the past grant cycle and plan for future to accomplish CHIP and State objectives.

Closing Out the Current Grant Cycle

- Previous funds will not carry forward into new grant cycle.
- Funding has remained stable with no immediate changes expected.
- Instructions on final progress report and program evaluation will be provided before last reporting period.
- Current activities and progress can be expected to continue into the future.
