Oral Health Program Director, Stanislaus County Health Services Agency

Senior Program Specialist, Local Oral Health Program/Tobacco Prevention Program, Mendocino County Public Health Department

Angela has been the county's Oral Health coordinator since January 2023. She continues to assist the Tobacco Prevention Program, which she managed from September 2021 through December 2022. Angela is looking forward to blending objectives and recruiting champions for both Oral Health and Tobacco Prevention. She originally joined Public Health in February 2019 to work with the 2020 Census Program. Angela brought together city governments, tribal governments, and numerous community-based organizations to form a countywide Complete Count Committee, whose purpose was to provide census outreach to the "Hard-to-Count" populations. Paula Lee, RDHAP, MPH

Dental Hygiene Consultant, Office of Oral Health, California Department of Public Health

Paula Dental Hygiene Consultant for the State of California. Her main role is the state coordinator of schoolbased/-linked oral health programs. Prior to working at the State, she worked 11 years at a Federally Qualified Health Center (FQHC) and private practice and volunteered in programs in Central America and Africa. For 10 years, Paula has volunteered to provide oral health care and oral health literacy in school-based/-linked programs to children, families, and community members in Nicaragua and Guatemala. Paula received an MPH from UC Berkeley in management and health policy and a BA in business administration from Sacramento State University. She currently serves on the Government Relations Council for the California Dental Hygiene Association and at the California Health Care Foundation Leadership Program where health care leaders expand skills and systems capacity to meet the challenges facing California's health care system.
