Who are we?


The Santa Barbara County Education

What are Community Health Worker Services? DHCS has recognized the service as "CHW/P/R"

- CHW/P/R services are now a Medi-Cal benefit, defined as:
 - Preventive health services to prevent disease, disability, and other health conditions or their progression; to prolong life; and promote physical and mental health
- Recognized effort to provide equitable, culturally competent services
 - Lived experience that aligns with and provides a connection between the CHW/P/R and the Member or population being served

Possible CHW/P/R Reimbursable Services We Include Are:

Health Navigation for students with identified health concerns

Health education (specialty trained depending on project)

Individual support or advocacy



Oral Health Specialized Training for CHW/Promotores



Once CHW/P are certified and are part of the Santa Barbara County Promotores Network a specialized Dental training is provided to the South and North County Region members who wish to help the Oral Health team during the school year.



Implementing CHW/P/R Billable Services



Who can provide/bill CHW/P/R services? How is it actually implemented in the community?



There has to be a "Supervising Provider" contracted with the local Medi-Cal Managed Plan and who is enrolled with the State Medi-Cal Program



There have to be certified CHW/P/Rs with lived experience that deliver the services who work for the supervising provider



Funding is routed through the local Managed Care Plan who contracts with providers and pays for the work. Ensures that supervising providers meet all qualifications



CFRS as a Supervising Provider

Our Qualifications:

- 1. CFRS is a Community Based Organization (501c3 Nonprofit Status)
- 2. Administrative structure in place to track CHW/P training, coordinate and monitor activities including experience billing Medi-Cal for some services through SBCEO's NPI
- 3. 15 year history of providing CHW/P/R services
- 4. Obtained NPI
- 5. Contracted with local MCP for CHW/P/R benefit
- 6. Enrolled in PAVE to become State MC provider



A **Supervising Provider** is the organization employing or overseeing the CHW/P/R, with which the managed care plan (MCP) contracts.

- Ensures that CHWs ensures CHWs have adequate supervision and training and maintains training records.
- Contracts and bills for CHW services.
- The Supervising Provider must be a licensed Provider, a hospital, an outpatient clinic, a local health jurisdiction (LHJ), or a community-based organization (CBO).
- New requirement 2024- Must enroll in the State Medi-Cal Program through PAVE
